For a valuable consideration, receipt of good will which is hereby acknowledged, the undersigned hereby grants to Jireh Entertainment Production, and the PROGRAM, "BUSKING WITH TALENT", its agents, employees, licensees, and successors in interest (collectively, the "Released Party") all ownership rights and the absolute and irrevocable right and permission to copyright, use and publish the recorded image and/or voice of the contestant (the "performance Image and/or Voice") that has been (or is being) obtained pursuant to this Consent and Release.

The undersigned waives any right that the undersigned may have to inspect or approve the Released Party's use of the Performance, Image and/or Voice, or the advertising copy or printed matter that may be used in connection with the use and/or publication of the Performance, Image and/or Voice. The undersigned releases the Released Party (and all persons acting under its permission or authority) from all claims for libel, slander, invasion of privacy, infringement of copyright or right of publicity, or any other claim related to the Performance, Image and/or Voice (collectively, "Claims"). This release includes without limitation any Claims related to blurring, distortion, alteration, optical illusion, digital alteration, use in composite form, whether intentional or otherwise, or use of a fictitious name, that may occur or be produced in the processing or publication of the Image and/or Voice.
